INSTRUCTIONS

1. As the Grower/Seller You must complete sections A, B, and C.
2. To transfer to a Grower/Buyer, you must nominate individual receipt dockets.
NOTE: If a docket has been split at the weighbridge split upon transfer to a buyer or has a mass breach transaction recorded against it or the docket cannot be nominated for a Grower to Grower transfer.
3. **You as the Grower/Seller** must sign section C and fax or email this form to the Grower/Buyer. If an agent/third party is acting on your behalf, a fully completed GrainCorp "Appointment of Agent" form must also be provided. This form is available from the GrainCorp website, www.graincorp.com.au.
NOTE: Please keep a copy of the fax sent confirmation/email sent for your records.
4. **The Grower/Buyer** must sign section D and fax or email this form to the GrainCorp Stocks Department. If an agent/third party is acting on behalf of the Grower/Seller, a fully completed GrainCorp "Appointment of Agent" form must also be provided. This form is available from the GrainCorp website, www.graincorp.com.au.
NOTE: Please keep a copy of the fax sent confirmation/email sent for your records.
4. Subject to verification, GrainCorp will execute the requested transfer(s). The effective date of transfer shall be the date on which the Grower's signed copy of this Form is received at the GrainCorp Stocks Department.
5. Once the Title Transfer is processed, you as the Grower/Seller will receive, where applicable, a Tax Invoice detailing outstanding storage charges and payment methods.
