



GrainCorp Confirms Harvest Management Scheme in Victoria

For the 2017/18 harvest, GrainCorp will participate in VicRoads' Grain Harvest Management Scheme (**GHMS**).

To comply with the scheme, GrainCorp staff will check for the sticker or interim permit before they process a delivery under the GHMS. This process supersedes GrainCorp's policies related to Victorian harvest deliveries that applied in previous years.

An example of the sticker and the interim permit is included on the following page.

Under the Victorian GHMS, there are no other changes to General Mass Limit (**GML**), the Concessional Mass Limit (**CML**), the Higher Mass Limit (**HML**), or the Performance Based Standards limit (**PBS**).

To participate in the scheme, delivery details will be recorded and provided to VicRoads. VicRoads can take further action related to the gross weight of the vehicle compared to the mass limit. Overloading offences carry substantial penalties under the Heavy Vehicle National Laws and associated legislation and regulations.

GrainCorp takes its role in the supply chain seriously and will be closely monitoring heavy vehicle loading during the harvest period.

Over Mass Limit Warning letters:

In the event a vehicle is in breach of their applicable vehicle mass, the truck driver will receive a warning letter on site highlighting the breach.

Mass Breach Advisory Notice:

In the event of breach of the Determined Mass Limit¹, you will effectively have the option to donate the net tonnes in excess of this amount to charity using GrainCorp's 'Mass Breach Buyer Account'.

Growers have 21 days to collect the amount of mass breach grain as from the date of delivery indicated on the Receival Docket given on tare. To collect such mass breach grain, growers must call GrainCorp Stocks (1800 809 482) and quote the Receival Docket Number and confirm a collection date and time. Fees and shrink will apply to any such collected mass breach grain as per the GrainCorp Storage and Handling Agreement or GrainCorp Grower

¹ Determined Mass Limit is calculated using the following formula: General Mass Limit x 1.075 + + 2 tonnes (if General Mass Limit is less than 50 tonnes) OR + 3 tonnes (if General Mass Limit is greater than 50 tonnes).

Example: Code 12 (6 axle semi-trailer) GML = 42.5 tonnes, warning notice above this for non GHMS, warning notice above 44.63 tonnes for GHMS, mass breach above 47.70 tonnes for GML, CML, HML and GHMS.

2017 GHMS Truck Codes

Trucks must display the VicRoads GHMS sticker or present the interim permit before GHMS is selected. Permit numbers do not need to be recorded. Owners of trucks that are newer than 2002 can apply to get a sticker via the VicRoads website.
